What makes PWLS unique among other youth sports organizations is its requirements for participants to maintain satisfactory progress in their academic studies. Our goal is to build sound minds and bodies for our leaders of tomorrow.

Because the above named participant has not met the PWLS scholastic standards, a **bi-weekly** progress report will be required; beginning **September 2, 2005**, for a total of four (4) reports from the child's learning institution. An original signed form **must** be provided to the head coach. No copies will be accepted. You will be unable to participate in any games unless your weekly progress report shows satisfactory progress for that 2 week period. At the end of the eight (8) week period, if the child has maintained at least three (3) reports of satisfactory progress, he/she will become certified for the remainder of the playing season. If unsatisfactory progress is reflected on any one of these reports or the child does not receive a progress report for a week, he/she will be ineligible to participate in that week's game. If the child does not have satisfactory progress for at least three (3) two week periods during this time, he/she will be removed from the National Roster and will not be eligible to participate in any remaining games.

As the above named participant has not met the Pop Warner Little Scholars (PWLS) scholastic requirements of a minimum GPA of 70% or higher, we, the undersigned, agree to the terms shown above as a condition to being placed on the National Roster.

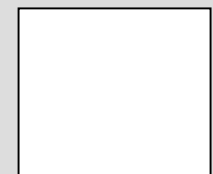

### Alternative Scholastic Certification Guidelines

1. This form must be completed with **all** signatures obtained
2. Bi-Weekly Progress Reports must be in player book prior to game day weigh in. If no progress report is received, the player is ineligible for participation in that week's game.
3. This form and bi-weekly progress reports must be kept in player book at all times.
4. If satisfactory progress is received, child may participate in that week's game.
5. If unsatisfactory progress for that week, child may **ONLY** be on the sidelines and the players' card will be marked as "fail" for any progress report showing unsatisfactory progress. Allowing the participant to play will be cause to apply rulings that apply to ineligible players.
6. At the end of the 4 report periods, a Conference Board member or a member of the Conference Scholastic Committee must certify eligibility for the remaining season.
7. Head Coach and/or parent/guardian will be required to come before the Pop Warner Board if found allowing an ineligible child to participate in any game.
8. Participant under academic review will be allowed to participate in all practices.
